**HOLD HARMLESS AGREEMENT**

1. I hereby acknowledge and agree that my participation in the VFW Riders event and specifically the motorcycle ride has inherent risks, even when the greatest care is taken, because the roads do not always have even surfaces, other participants may interfere with my riding activity, and riding is a strenuous physical activity. I also hereby acknowledge and agree that I have full knowledge of, understand, and appreciate the nature and extent of such risks, including the risks of cuts, abrasions, severe bodily injury, death, or property damage resulting from any of the following occurring while participating in the ride: (1) falling on the ground, (2) falling against physical objects or structures, (3) being bumped, knocked down, stepped on, crushed, or kicked, whether done intentionally or not, by other riders, and (4) improper use of motorcycles or failure to use safety equipment, such as helmets. I further acknowledge and agree that the above list does not include all possible risks associated with participating in the ride and that the above list in no way limits the extent or reach of this release of liability and hold harmless agreement.

2. I hereby certify that I am voluntarily assuming all the risks associated with my participation in the motorcycle ride. I understand that I will be solely responsible for any loss, injury, or damage, including death, which I may sustain while participating in this ride or event, and that by this agreement, I am waiving any right to assert any and all causes of action, claims, or demands of any nature whatsoever, against the Veterans of Foreign Wars, Veterans of Foreign Wars Riders, and their officers, agents, or employees, for such loss, injury, damage, or death, even if caused by their ordinary negligence.

- 3a. I certify that I am of lawful age (18 years or older) and otherwise legally competent to sign this release of liability and hold harmless agreement. I further certify that I understand that the terms of this document are legally binding, that I agree to these terms, and that I am signing this document, after having carefully read it, of my own free will.

- 3b. I certify that I am the parent or legal guardian of the participant who is under the age of 18. I further certify that I am legal able to sign on behalf of the participant, agree to their participation in the event and accept all risks associated with that participation.

I certify that I am in the proper physical and mental condition to endure any ride, am able to control the motorcycle I am riding during unforeseen weather, will not hold the Veterans of Foreign Wars, Veterans of Foreign Wars Riders, or anyone other than themselves responsible for any accident or mishap.
